We do not provide or sell individual users' information to advertisers. However, we use the information to create a profile of who our readers are.

3: Transfers to Countries Outside of the EU/EEA

We may, on rare occasions, transfer your personal data to countries outside of the EU/EEA (USA and Canada). Transfers to these third countries will only take place for specific purposes, as mentioned in section 2, and in the event of a transfer to a country outside the EU/EEA, we will always ensure that appropriate safeguards are in place.

4: Your Rights

You have the following rights:

- You have the right to request access, rectification, or erasure of your personal data.
- You also have the right to object to the processing of your personal data and to have the processing of your personal data restricted.
- In particular, you have an unconditional right to object to the processing of your personal data for direct marketing purposes.
- If the processing of your personal data is based on your consent, you have the right to withdraw your consent at any time. Your withdrawal will not affect the lawfulness of the processing carried out prior to the withdrawal of your consent.
- You have the right to retrieve the personal data you have provided in a structured, commonly used, and machine-readable format (data portability).
- You also always have the right to file a complaint with a data protection supervisory authority, such as Datatilsynet (the Danish Data Protection Agency).

Cookie Policy

This Website uses cookies and below we will describe which cookies are used, for what purposes, and how you can avoid and delete cookies.

1: Cookies

A cookie is a small text file that is stored in your browser and used to recognize your computer when you return. A cookie may contain text, numbers or, for example, a date, but no personal information is stored in our cookies. A cookie is not a program and cannot contain a virus.

When you visit our Website, you automatically receive one or more cookies.

2: How Long Are Cookies Saved?

Different cookies have different lifetimes, depending on their function. When a cookie reaches its set lifetime, it deletes itself. With each new visit to the Website, all cookies are renewed.

3: How to Avoid and Delete Cookies

If you don't want to store cookies on your computer, you can choose to not receive cookies and to delete cookies stored on your hard drive.

However, as a user you should be aware that the functionality of the Website will not be 100% optimal if you delete or block cookies.

In order to determine who visits our Website, we use cookies to save demographic and user-related statistics. This allows us to tailor and create content and services to suit your, and other users', interests and preferences.

4.1: Third Party Cookies - Google Analytics

User-related statistics are collected via the analytics.js cookie. No personal data is collected. The cookie collects information about your device's location based on its IP address, which pages you visit on www.aguagain.dk, and the amount of time you spend on them. We use this knowledge to optimise www.aguagain.dk and in order to give you the best possible experience. We use systems from Google Analytics.

4.2: Other Third Party Cookies
